CONTEST RULES & REGULATIONS

Eligibility

- 1. This contest is open to any individual whose principal residence is Chilliwack, British Columbia, Cultus Lake, British Columbia, Agassiz, British Columbia, Harrison Hot Springs, British Columbia or Abbotsford, British Columbia and who is at least 19 years of age on the date that such individual enters the contest.
